**\*OLD BUSINESS**

- Grant Updates – Ross Evelsizer updated the Board on a number of grants that are in progress, past applications, or coming available
  - Tile Outlet Monitoring - Results from tile monitoring were shared with the board. The results from sites in the TRW were conglomerated with other sites around the state.
  - Champion Producers Conservation Innovation Grant - RC&D is working with TRW producers to promote champion conservation producers through professional photos and media materials. Part of this outreach includes a webpage at [turkeyriver.org/producers](http://turkeyriver.org/producers)
  - RCPP – The TRW RCPP application was moved forward and invited to submit a final application. The application is \$2.75 M for flood reduction and water quality improvement practices.
  - NFWF and Leopold Center - RC&D partnered with the Iowa Soybean Association to apply for grants from the National Fish and Wildlife Foundation and the Leopold Center for Sustainable Agriculture. Each of these preproposals was accepted and RC&D was invited to submit a final application for each. RC&D and ISA would work with producers to analyze land in production for return of investment. Areas that were not productive and incurring cost to the producer would be recommended to have alternative management.
- Field Day with Iowa Corn Growers Association – The field day has been postponed to a date TBD after harvest season.

**\*NEW BUSINESS**

- Iowa Flood Center Update – Breanna Zimmerman updated the board on the placement of rain gauges in the TRW. Rain gauges are currently being installed and will be in place through November. Antonio Arenas then presented to the board on shallow ground water well data that is being incorporated into the IFC models.
- Otter Creek Update – Rod Marlatt updated the board on the construction progress of several projects in Otter Creek. Rod has also recruited several more landowners to participate in flood reduction projects. Fayette County will also be putting in several on-road detention structures as part of the project.
