- Draft Application for Watershed Planning Grant  
Lora Friest, Northeast Iowa RC&D, handed out a Draft Application for the Watershed Planning Funding made available through the Iowa Economic Development Authority and Iowa Department of Natural Resources. Mrs. Friest summarized the application and discussed all points on the handout "Summary of the Planning Process", and asked for input on developing the draft application. Discussion Points: Application is due September 24<sup>th</sup>. Iowa Economic Development Authority anticipates funding three watershed management authorities. McCartney suggested adding an inventory of existing funding sources.
